THE SCHEDULE OF APPROVAL

1. PRODUCT DESCRIPTION :

A-30 Class Steel Deck insulated with "PAROC Marine Fire Slab 80, 40 mm" (stiffeners of special design and partially insulated)

Steel deck insulated with mineral wool type "PAROC Marine Fire Slab 80" (nominal density of 80 kg/m³).

The insulation is applied in one layer of 40 mm between the stiffeners. The stiffeners (168 x 70 x 8 mm) are insulated with a layer of 40 mm. The insulation extended 160 mm down the stiffeners. Stiffeners that are less than 160 mm high shall be fully insulated.

The insulation is fastened with steel pins.

Maximum distance between fastening pins : 300 mm

2. DOCUMENTS AND DRAWINGS :

As per the Manufacturer's drawing n°16001 dated 10/02/2016.

3. TEST REPORTS :

Test report n° 2016CS01482/1 dated 21/03/2016 as per IMO 2010 FTP Code Annex 1 Part 3, from RINA Laboratory, Italia.

4. APPLICATION / LIMITATION :

4.1 - The following component(s) shall comply with the requirements of the relevant Bureau Veritas rules and be type approved:

- the insulation "**PAROC Marine Fire Slab 80**",
- any added finish surface material(s).

4.2 - The fitting aboard to be the same as used for the test.

5. PRODUCTION SURVEY REQUIREMENTS :

5.1 - The product "**A-30 Steel Deck insulated with "PAROC Marine Fire Slab 80, 40 mm"** are to be supplied by **PAROC GROUP OY** in compliance with the type described in this certificate.

5.2 - This type of product is within the category HBV of Bureau Veritas Rule Note NR320 and as such does not require a BV product certificate.

5.3 - **PAROC GROUP OY** has to make the necessary arrangements to have its works recognised by Bureau Veritas in compliance with the requirements of NR320 for HBV products.

6. MARKING OF PRODUCT :

The product or packing is to be marked with manufacturer name, type, designation and fire-technical rating.

7. OTHERS :

It is **PAROC GROUP OY**'s responsibility to inform shipbuilders or their sub-contractors of the proper methods of fitting, use and general maintenance of the approved equipment and the conditions of this approval.
